

Privacy Policy

Taiwan Semiconductor Co., Ltd. ("TSC") operates www.taiwansemi.com (the "Site"). This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from TSC's website and any other source.

We use your Personal Information only for providing and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy.

Information Collection and Use

While you use our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. TSC uses, including Personal Information, in several ways. TSC uses the data it collects for the following purposes:

- (1) to process transactions for the sale and support of TSC products and/or services
- (2) to operate TSC's business, and to provide and support the products and services TSC offers (including improving and personalizing)
- (3) to send certain communications, including promotional communications. Personally identifiable information ("Personal Information") may include:

contact details, such as your name, title, company/organization name, job title, e-mail address, telephone numbers, nationality and country of residence and physical address;

information that assists us in identifying the products and services that best meet your requirements including Technical Question, Sample Request, Contact Request; general Feedback from you about our sites and our products and services.

You are not required to provide any of this information, but if you do not, we may not be able to provide you with the requested service.

Disclosure of Personal Information to Subsidiaries or Third Parties

TSC will not rent or sell your Personal Information to others but may disclose personal information with subsidiaries, third-party vendors and service providers that work with TSC. We will only share Personal Information to these parties to help us provide a product or service to you. Such parties will be bound by data processing agreements ensuring the protection of your personal data.

Links to other sites

Our contact us page and homepage contains links to other websites. These are integrated into our website as simple links to the services. Clicking on the integrated icon or link takes you to the page of the relevant provider i.e. only then is user information passed on to the provider. TSC has no control over those sites and is not responsible or liable for the policies and practices followed by third parties.

Log Data

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data").

This Log Data includes the following information: your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics.

We collect information about your visit to our sites, including what pages you view, the number of bytes transferred, the links you click, the materials you access and other actions taken within TSC sites. In addition, we may use third-party services such as Google Analytics that collect, monitor and analyze this information.

Communications

We will use your Personal Information to contact you with newsletters, marketing or promotional materials and other information about product and service.

Cookies

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Like many sites, we use cookies to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is sent. However, if you do not accept cookies, you may not be able to use some portions of our Site.

Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage, is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.
